

Leveraging Momentum & Opportunities

2011 - Santa Ana youth, parents, and organizations came together to discuss problems in the Santa Ana Unified School District (SAUSD) and the Orange County youth detention/deportation, and school-to-prison-pipeline crisis.

Coincided with statewide and national discussions about the school-to-prison pipeline and the relationship between trauma, unfair treatment of students of color, lgbtq students and students with disabilities, school discipline, school climate, and Restorative Justice Practices.





Using LCAP as a vehicle, we focused on dismantling the school-to-deportation-to prison pipeline by addressing the school climate, parent and youth engagement priorities of the LCAP.

While the school district held its own listening sessions, we came together with the help of Public Counsel and developed a 5-page School Climate Resolution.

From that resolution, community members identified the LCAP priorities.



LCAP Wins

Provide professional development for teachers to promote the successful implementation of the new CA State Standards, effective technology integration, engagement of restorative justice strategies, and methods to increase the number of recipients of the State Seal of Biliteracy. - \$3.9 million

Address language barriers by ensuring access for parents of EL students to English classes, including online learning resources and courses offered through the community college, and develop native language translations of website (Spanish & Vietnamese). - \$1 million

Support school and district operations to create welcoming and productive school environments. Conduct "anti-bullying awareness" and "safe and sensitive schools" campaigns that include outreach efforts to staff, parents, and students. - \$16 million

School Climate Committee

Supportive Schools Climate Partnership Committee: Establish a pro-active relationship with the Supportive School Climate Partnership Committee led by parents, students and community members to help shape and support a safer and more positive and nurturing school climate.


LCAP: Ensure access for low income pupils to the core instructional program by including, but not limited to, Positive Behavior Interventions and Supports (PBIS) training, Implementation of restorative justice strategies, expanding drop-out prevention and retention efforts, mentoring, increasing nursing services, nutritious food, intramural sports, and other wellness programs. Expand School Climate Oversight Committees that include parents and students. - \$6 million

Successes • RJ: Allocation of funds to train school staff on RJ, Hiring RJ Specialist • Hiring of the #CIW and RJ Coordinators at 17 schools • 3 grant = 5 liaisons, 25 schools • Funding for additional mental health specialists in the district - • Decreasing youth arrests/referrals to probation - • Parent Centers - • Board Policies and Administrative Regulations - • School Discipline, Bullying, Conduct, Harassment, Suicide Prevention • Increased sharing of data
